Item 9 : The Governing Body recorded that as per notification no. R&P/017/2024/035 dated July 11, 2024 issued by the University of Delhi, the cases where only the date of eligibility was deferred/changed due to non-completion of the relevant training/workshop/course as per the earlier provisions but the period of assessment was not changed, the deferred/changes date of eligibility may be restored after due scrutiny administratively i.e. by IQAC and Principal with prior approval of competent authority.

The Governing Body noted that in light of the said notification, Dr. Sonal Babbar, Associate Professor in the Department of Commerce, Dr. Priti M. Arora, Associate Professor in the Department of Economics and Dr. Saroj Rani, Associate Professor in the Department of Economics had represented their cases for the restoration of the date of eligibility as the period of assessment has not changed.

The Governing Body, after going through their APAR, PBAS and recommendations of the IQAC, was of the view that as there is no change in their period of assessment, therefore, the original date of eligibility may be restored as detailed below:

- Item 13 : The Governing Body recorded that Mr. Satya Dev Singh, Laboratory Assistant, Department of Physics will be retiring on May 31, 2025 (afternoon) on attaining the age of superannuation. The Governing Body also recorded that Mr. Raj Kumar, Laboratory Assistant, Department of Botany will be retiring on July 31, 2025 (afternoon) on attaining the age of superannuation. The Governing Body noted that their retirement benefits will be released as per the University rules.
- Item 14 : The Governing Body noted that Mr. Jaspal Singh Rekhi, Ex-Administrative Officer retired from the College services on October 31, 2009 and expired on September 8, 2017. The College received a request from Mr. Gagandeep Singh Rekhi, nominee of Late Mr. J. S. Rekhi, to release his pension arrears. As per office records, at the time of his death, Mr. Rekhi was drawing the pension as per 6th Pay Commission and later his pension was revised according to 7th Pay Commission by the University of Delhi vide letter no. Fin./Pen.Cell/F-43/2023/7477 dated March 7, 2023. The Governing Body permitted the College to release the arrears of pension amounting to Rs. 1,15,032/- to Mr. Gagandeep Singh Rekhi, nominee of Late Mr. J. S. Rekhi.
- Item 15 The Governing Body recorded that the University of Delhi vide circular no. CB-III/Circular/2025/Vol. II/226 dated 28.04.2025 has directed all the colleges to gift a wrist watch to all the employees who were working or have retired in the centenary year i.e. from May 1, 2022 to June 30, 2023. The University has also provided the models of the wrist watch for the male and female staff. The approximate cost per watch is Rs. 2300/-. During the said period, 158 employees (74 Teaching Staff, 73 Non-Teaching Staff & 11 retired members) were working in the permanent capacity in the College. Therefore, the Governing Body approved the estimated expenditure of Rs. 3,63,400/- for the said purchase.
- Item 16 : The Governing Body noted that the three-year tenure of the present Internal Committee (IC) against sexual harassment at the workplace has come to an end. Therefore, the Governing Body approved the proposed nominations for the new Internal Committee as detailed below:

- Item 17: The Governing Body recorded that the College has entered into mutual collaboration agreement with M/s. Vikas Lifecare Limited (VLL) on 'Designing of Smart Nanocomposites' for a period of three years w.e.f. March 26, 2025. The Governing Body noted that for this joint collaboration, they have given the equipment worth Rs. 5,85,000/- to the Department of Chemistry of the College. In addition to this, VLL has provided the necessary chemicals and glassware with a proper record amounting to Rs. 5,26,346/-. A Project Assistant, Ms. Barkha, has been appointed and the expenditure towards her salary (Rs. 20,000 per month) will be borne by VLL and disbursed by the College. She will be working on this project under the guidance of the Principal and Dr. Hema Bhandari, Associate Professor, Department of Chemistry. A cheque amounting to Rs. 2,50,000 towards her salary and miscellaneous expenditure has been given by VLL.
- Item 18 : The Governing Body recorded that the College has received 74 proposals for the summer internship programme from the faculty members across different departments of the College. The total funding requested is Rs. 1,27,000/-. The Governing Body approved Rs. 5,00,000/- for the same keeping in mind the fact that some other faculty members may seek financial assistance towards research or infrastructural development in the near future.
- Item 19 : The Governing Body examined the stock verification report of the Library for the year 2024-2025. As per the report, 10 canned chairs, 05 steel racks and 09 UPS need to be written off as they are not serviceable/repairable. The Governing Body was of the view that these items should be written off as per rules.
- Item 20 : The Governing Body recorded that the University of Delhi vide notification no. Acad.I/Fee/2025-26/195 dated April 30, 2025 has notified a revision in University dues from Rs. 2,900/- to Rs. 3,500/- for first-year students effective from the academic year 2025-26. The Governing Body approved the same.

- Item 21 : The Governing Body approved the payment of Rs. 18,000/- to Shri Mohinder J. S. Rupal, Advocate of the College, towards appearance/conference/miscellaneous expenditure in the High Court/Patiala House Court on different dates for representing the College in the following cases:
 - 1. Ranjit Singh Vs. University of Delhi and Ors.
 - 2. Mangat Rai Malik Vs. University of Delhi and Ors.
 - 3. Dharmvir Vs. University of Delhi and Ors.
 - 4. Ritu Dhingra Vs. Maitreyi College and Ors.
- : The Governing Body noted that M/s. Mi2C Security and Facilities Pvt. Ltd., which is providing Housekeeping and Security services to the College, has requested for revision of minimum wages as per Govt. of NCT of Delhi (Labour Department) vide its order F.No. (142)/02/MW/VII/Part file/211-241 dated April 15, 2025. The Governing Body also noted that the effective date of revision of rates is from April 1, 2025. The Governing Body approved the revision of wages as per the minimum wages notified by the Government of NCT of Delhi, subject to submission of the receipt of provident fund deposited with ESI by M/s. Mi2C Security and Facilities Pvt. Ltd. The Governing Body also approved the revision of wages, in light of above notification, for those employees of the college who are working on daily wages.
- Item 23 : The Governing Body noted that with the implementation of the Four-Year Undergraduate Programme under the National Education Policy (NEP), all the undergraduate programmes will now include a fourth year of study. This will lead to a substantial increase in student strength, thereby, creating a need for additional academic and co-curricular spaces within the College. The Governing Body was informed that two existing Bamboo Rooms (No. 2 and 3) in the College are very old and in a dilapidated condition. They are no longer fit for safe and effective use. Therefore, these two bamboo rooms need to be replaced with two porta cabins. The Governing Body approved the construction of two porta cabins at the estimated cost of ₹27,74,121/- from the Students Fund of the College.
- Item 24 : The Governing Body noted that with the implementation of the Four-Year Undergraduate Programme under the National Education Policy (NEP), the academic delivery of certain Skill Enhancement Courses (SEC) and Value Addition Courses (VAC) necessitates the use of advanced teaching aids. Therefore, there is a requirement for the procurement of 25 interactive panels/Projectors to enhance classroom teaching and ensure effective pedagogical outcomes as detailed below. The approximate cost for the proposed procurement is ₹49,35,000/-.

The Governing Body permitted the College to procure 25 interactive panels/projectors through open bidding on the Government e-Marketplace (GeM) and/or Central Public Procurement (CPP) Portal, in accordance with the prevailing rules and procurement procedures. The said expenditure can be met from the Students Fund of the College.

- Item 25 : The Governing Body approved the estimate amounting to Rs. 38,09,998.74/- for the repair and renovation of the Computer Laboratories (Nos. 1,2,3 and 4) and Chemistry Laboratories (No. 1, 2 and 3) from the internal receipts generated by the College.
- Item 26 : The Governing Body noted that the College needs to procure student desks, tables, chairs for several classrooms and tables, chairs and almirahs for the departmental rooms as the existing furniture is approximately twenty years old and is no longer in a serviceable condition. Also, to accommodate the students, who would be pursuing fourth year, there is a need for additional furniture. The approximate cost of the same is Rs. 62,93,700/-. The Governing Body permitted the College to procure the furniture, as detailed in the agenda papers, through the Government e-Marketplace (GeM) and/or Central Public Procurement (CPP) Portal by inviting competitive e-Tender/bids, in accordance with the prevailing rules and procedures for public procurement. The said expenditure can be met from the Students Fund of the College.
- item 27 : The Governing Body permitted the College to purchase 20 air-conditioners, as detailed below, at the estimated cost of Rs. 9,70,000/- through the Government e-Marketplace (GeM) portal after following due procedure. The said expenditure can be met from the Students Fund and the Hostel Fund.

- 2. Repair and renovation work of old science block and waterproofing work of the roof of the old science block.
- 3. Exterior repair and renovation work Administration, Library, Science Block and other connected area.
